### **BATTLE OF FORT CRAWFORD**

The 2<sup>d</sup> Battle of Fort Crawford will be fought on 2–4 October on private land near Hallsville about a mile east of Longview.<sup>1</sup> The 1<sup>st</sup> Battle of Fort Crawford was fought last year and ended in a resounding Confederate victory. But the Yankees are back, and they're spoiling for another whipping. And we're just the outfit that can give it to them.

Fort Crawford was a real fort, though only during pre-war times. It was built in the 1840s as a protection against hostile Indians. By 1849 the fort had a post office and a twostory building that served as a school, a church, and a Masonic hall. When the railroad bypassed the fort in 1869, it's heyday was over. All that remains today is a cemetery.

This is a serious reenactment, especially for those who enjoy Confederate camp life. Even if you're just a spectator, it should be a lot of fun.
